

The CPA Referral Service

The CPA Referral Service is designed to help the public find a CPA to assist them with a variety of services. When a business or individual needs to find a CPA firm, they often call the Society or visit our web site. The CPA Referral Service allows a person or business to search for a CPA firm by choosing a location and any combination of 60+ service sectors as criteria. Once their criteria are entered, the database quickly produces matches to meet their needs.

To include your firm in our online referral service it must meet the following criteria:

- The firm must be licensed and in good standing with the Alabama State Board of Accountancy to practice public accounting.
- The firm must have at least one staff member who is an ASCPA member.
- The firm must notify the ASCPA that they would like to be included in the public online directory.
